Terms & Conditions

1. Promotion Period

This promotion (“Promotion”) is organised by Global Wealth Digital Pte. Ltd. (“Beansprout”). It is an exclusive Beansprout campaign run in conjunction with the qualifying broker promotions available on the Beansprout website.

The Promotion will run from 10 June 2026, 00:01 (SGT) to 19 July 2026, 23:59 (SGT), both dates inclusive (“Promotion Period”).

Weekly draws will be conducted on 18 June 2026, 25 June 2026, 2 July 2026, 9 July 2026, 16 July 2026, and 23 July 2026 for eligible participants from the respective qualifying periods set out in Clause 5.

2. Eligibility

2.1. The Promotion is open to all Singapore Residents aged 18 years and above, including Singapore Citizens, Permanent Residents, and valid Employment Pass or S Pass holders.

2.2. Each qualifying broker promotion may carry its own eligibility conditions (including restrictions on existing account holders). Participants must satisfy the eligibility requirements of the relevant broker promotion in addition to these Terms & Conditions.

2.3. Employees of Beansprout and the participating brokers, and their immediate family members, are not eligible to participate.

2.4. By participating in the Promotion, each participant agrees to be bound by these Terms & Conditions and all decisions made by Beansprout, which shall be final and binding.

3. Eligible Customer Requirements

To qualify as an “Eligible Customer” and be entered into a draw, participants must complete all of the following during the Promotion Period:

- i. Sign up for a new trading account with any one of Beansprout’s eligible partner brokers (Longbridge, Moomoo, Webull, IG Markets, or Tiger Brokers) through Beansprout’s designated affiliate link;
- ii. Have the account application successfully approved by the relevant broker;
- iii. Fund the account with the minimum qualifying amount specified in that broker’s Beansprout promotion. The minimum funding requirement is governed by the terms and conditions of each respective broker promotion and may differ between brokers;
- iv. Complete and submit the official Beansprout reward form after the account has been successfully opened. The form must include the participant’s registered email and mobile number, and the broker through which the qualifying account was opened, for verification purposes.

For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the account with the specified qualifying amount and is not required to subscribe to or purchase any capital markets products or investment products and/or initiate any transactions or dealings in capital markets products or investment products.
