Terms & Conditions

1. Promotion Period

The Beansprout x Longbridge Festive Rewards Draw (“Promotion”) is organised by Global Wealth Technology Pte. Ltd. (“Beansprout”) in partnership with Longbridge Securities Pte. Ltd. (“Longbridge SG”).

The Promotion will run from **1 February 2026 to 28 February 2026**, both dates inclusive (“Promotion Period”).

Weekly draws will be conducted on **9 February, 16 February, 23 February, 2 March 2026** for eligible participants from the respective qualifying weeks.

A **Grand Draw** will be conducted on **2 March 2026** for all eligible participants who signed up during the entire Promotion Period.

2. Eligibility

2.1. The Promotion is open to all Singapore Residents aged 18 years and above, including Singapore Citizens, Permanent Residents, and valid Employment Pass or S Pass holders.

2.2. Existing Longbridge SG account holders are not eligible for this Promotion.

2.3. Employees of Beansprout, Longbridge SG, and their immediate family members are not eligible to participate.

2.4. By participating in the Promotion, each participant agrees to be bound by these Terms & Conditions and all decisions made by Beansprout, which shall be final and binding.

3. Eligible Customer Requirements

- iii. Have the application for the Longbridge SG account successfully approved by Longbridge SG;
- iv. Fund the Longbridge SG account with a minimum deposit of S\$2,000 within the Promotion Period; and
- v. Complete and submit the official Beansprout Google Form after the Longbridge SG account has been successfully opened. The form must include the participant’s registered email and mobile number for verification purposes.

For the avoidance of doubt, in order to comprise “Eligible Customers”, a user is only required to fund the Longbridge SG Account with the specified amount and is not required to subscribe to or purchase any capital markets products or investment products and/or initiate any transactions or dealings in capital markets products or investment products.

4. Referral Entries

- Each **successful referral** (i.e., when the referred friend meets the eligibility criteria in Clause 2) will grant the referrer **one additional chance** in both the weekly draw and the grand draw.
