

Beansprout x Longbridge Referral Campaign

Terms & Conditions

1. Campaign Period

This campaign ("Campaign") is organised by **Global Wealth Technology Pte. Ltd.** ("Beansprout") in partnership with **Long Bridge Securities Pte. Ltd.** ("Longbridge SG").

The Campaign will run from **1 January 2026, 00:01 (SGT)** to **31 January 2026, 23:59 (SGT)**, both dates inclusive ("Campaign Period").

Beansprout reserves the right to amend or extend the Campaign Period at its sole discretion without prior notice.

2. Campaign Eligibility

The Campaign is open **exclusively to Singapore residents** aged 18 years and above. Singapore residents refer to users residing in Singapore including Singapore Citizens, Singapore Permanent Residents, holders of valid and current employment or work passes issued by the Ministry of Manpower, or individuals with a valid Singapore residential address.

a. Referrer

Refers to a person who:

1. Has previously participated in a Beansprout promotion, successfully signed up for a Longbridge SG account via Beansprout, and received a voucher reward from Beansprout; and
2. Shares the **exclusive promo code "UI2XT9LU"** with friends and family during the Campaign Period.

b. Referee

For Referrers

For Referees

1. Register for a **new Longbridge SG account** for the first time via Beansprout’s referral link.
2. Enter the **exclusive promo code “UI2XT9LU”** during account registration.
3. **Fund at least S\$2,000** into your Longbridge SG account
4. **Submit your details via Beansprout’s official Google Form**, including your registered email, mobile number, and your referrer’s email address.
5. Upon verification, both referrer and referee will qualify for rewards as described in Clause 4.

For the avoidance of doubt, to qualify as an “Eligible Customer”, a user is only required to fund the Longbridge SG Account with the specified amount and is **not required to subscribe to or purchase any capital markets products or investment products and/or initiate any transactions or dealings** in such products.
