

## **Beansprout x Webull Promotion – Terms & Conditions**

### **1. Promotion Period**

- 1.1. The Beansprout x Webull New Customer Promotion (“Promotion”) is organised by Global Wealth Technology Pte. Ltd. (“Beansprout”) in partnership with Webull Securities (Singapore) Pte. Ltd. (“Webull SG”).
- 1.2. The Promotion will run from 1 March 2026 (00.01 am SGT) to 31 March 2026 (11.59 pm SGT) both dates inclusive (“Promotion Period”).
- 1.3. Beansprout reserves the right to amend or extend the Promotion Period at its sole discretion without prior notice.

### **2. Eligibility**

- 2.1. The Promotion is open to Singapore Residents aged 18 years and above.
- 2.2. This Promotion is strictly limited to individuals who have not previously funded a Webull account prior to the Promotion Period and who have not opened and subsequently closed a Webull account.
- 2.3. Existing Webull SG account holders are not eligible for this Promotion.
- 2.4. Employees of Beansprout, Webull SG, and their immediate family members are not eligible to participate.
- 2.5. By participating in this Promotion, participants agree to be bound by these Terms & Conditions and all decisions made by Beansprout, which shall be final and binding.

### **3. Eligible Customer Requirements**

3.1. To qualify as an “Eligible Customer” and receive a Promotion Reward, participants must meet all of the following conditions during the Promotion Period:

- i. Successfully sign up for a new Webull SG account via Beansprout’s designated referral link;
- ii. Have their Webull SG account application successfully approved by Webull SG;
- iii. Deposit fresh funds into their Webull SG account according to one of the qualifying tiers below:
  - Deposit a cumulative amount of at least S\$3,000 within promotion period → Eligible for a NTUC FairPrice voucher worth S\$50
  - Deposit a cumulative amount of at least S\$10,000 within promotion period → Eligible for NTUC FairPrice vouchers worth S\$100

iv. Submit their details via Beansprout’s official Google Form for verification purposes.

3.2. Deposits must be made within the Promotion Period to qualify.

3.3. For the avoidance of doubt, participants are only required to deposit the qualifying amount and are not required to execute any trades or purchase any investment products.

3.4 For deposits made in currencies other than Singapore Dollars (SGD), the amount will be converted to its SGD equivalent based on the following exchange rates: USD 1 = 1.3704 SGD and HKD1 = 0.1746SGD. The converted SGD amount will be used to assess the participant’s eligibility for the rewards.

#### **4. Promotion Rewards**

- 4.1. Eligible Customers who meet the S\$3,000 deposit requirement will receive one (1) S\$50 NTUC FairPrice voucher.
- 4.2. Eligible Customers who meet the S\$10,000 deposit requirement will receive two (2) S\$50 NTUC FairPrice voucher.
- 4.3. Each Eligible Customer is entitled to only one reward tier.
- 4.4. Rewards are non-transferable, non-exchangeable, and not redeemable for cash.
- 4.5. Beansprout reserves the right to substitute the reward with another item of equivalent value without prior notice.

#### **5. Verification and Fulfilment**

- 5.1. Beansprout reserves the right to verify participant eligibility, account approval status, and deposit fulfilment with Webull SG.
- 5.2. An eligible user whose email address and contact number have been accurately provided will receive the voucher at the submitted email address once eligibility has been successfully verified. The voucher notification email will be sent from [no-reply@fairprice.com.sg](mailto:no-reply@fairprice.com.sg). Eligible users are encouraged to check spam/junk folders if it has not been received as there may be accidental redirects by the email client.
- 5.2. Rewards will be issued within 10 working days after successful verification.
- 5.3. Participants who fail to submit the Google Form or provide accurate information may be disqualified.
- 5.4. Incomplete, duplicated, or fraudulent submissions will be rejected.

#### **6. Disqualification**

Beansprout reserves the right to disqualify any participant who:

- Provides false or misleading information;
- Does not meet eligibility or deposit requirements;
- Attempts to abuse or manipulate the Promotion; or
- Breaches these Terms & Conditions.

- 7.2. Beansprout reserves the right to modify, suspend, or terminate the Promotion at any time without prior notice.
